CONDITIONS FOR EXHIBITORS

1. In these conditions:-

Entry Form	<i>means</i>	the entry form attached to these conditions.
Exhibitor	<i>means</i>	the person named on the Entry Form.
Lampport Hall	<i>means</i>	Lampport Enterprises Ltd.
Exhibit	<i>means</i>	the exhibit described on the Entry Form.
Festival	<i>means</i>	the Lampport Festival of Country Life on 27th and 28th May 2018
Site	<i>means</i>	the land of Lampport Hall, Northamptonshire designated by Lampport Hall for the Festival including the parking and camping areas.
H.V.T.C.	<i>means</i>	Hannington Vintage Tractor Club
2. The Entry Form is an "offer" by the Exhibitor, which might be accepted (and so constitute a contract) by the countersignature of a copy on behalf of Lampport Hall and H.V.T.C. it being sent by class post to the address given by the Exhibitor on the Entry Form and once such copy is sent the following conditions shall apply.
3. The Exhibitor shall show the Exhibit at the Festival.
4. Lampport Hall shall allow the Exhibitor to show the Exhibit at the Festival.
5. Either party might cancel this contract at any time before **26th May 2018** sending to the other by first class post a notice stating that this contract is cancelled. If sent by H.V.T.C. it should be addressed to the address given on the Entry Form. If sent by the Exhibitor it should be addressed to "The Rally Secretary HVTC, 21 Mulso Road, Finedon, Northants NN9 5DP. Neither party shall have any liability in the event of such cancellation.
6. H.V.T.C. agrees to pay the Exhibitor for showing the Exhibit at the rate shown on the Entry Form (if any) by dispatching a cheque by first class post made payable to the Exhibitor to the address given on the Entry Form by the end of **June 2018** after the receipt of an invoice addressed to "H.V.T.C." for the correct amount. Payment will only be due if the Exhibitor has fully complied with all of the conditions **and by previous agreement with H.V.T.C..**
7. The Exhibitor must have in place **public liability insurance of at least £5 million.** The Exhibitor must produce proof of such insurance on request and the insurance should indemnify H.V.T.C and Lampport Hall Trust.
8. The Exhibitor of all steam engines must present a copy of their boiler certificate on request.
9. If the Exhibitor or someone on his or her behalf is to drive a vehicle on the Site that person must hold a full driving licence applicable to that vehicle. No movement of vehicles is permitted on site without direction by **a Site Official.**
10. H.V.T.C does not accept any responsibility for loss or damage to property on the Site at any time.
11. Lampport Hall will allow camping by the Exhibitors on the Site between midday on **24th May 2018 and midday on 29th May 2018.**
12. The Exhibitor will comply with any directions given from time to time by or on behalf of H.V.T.C and Lampport Hall in relation to the conduct of the Festival or the use of the Site and the following directions will apply:-
 - a. Camping shall be in a location to be specified.
 - b. The Exhibit will be set up in a location to be specified.
 - c. The Site must be left in a clean and tidy condition.
 - d. The Exhibitor must sign out with a steward.
 - e. No tombola society stands will be allowed without prior permission.
 - f. Vehicles **must** be parked in the parking area **before the Festival opens.**
