CONDITIONS for Traders

1. In these conditions:-

Entry Form	<i>means</i>	the entry form attached to these conditions.
Trader	<i>means</i>	the person named on the Entry Form.
Lampport Hall	<i>means</i>	Lampport Enterprises Ltd.
Stand allocated	<i>means</i>	the stand of the approximate dimensions stated on the Entry form to the Trader by Lampport Hall and H.V.T.C..
Festival	<i>means</i>	the Festival of Country Life on 27th and 28th May 2018.
Site	<i>means</i>	the land of Lampport Hall, Northamptonshire designated by Lampport Hall for the Festival including the parking and camping areas.

2. Submission of an Entry Form together with payment of the amount shown on the Entry Form is an "offer" by the Trader which might be accepted (and so constitute a contract) by the countersignature of a copy on behalf of Lampport Hall and H.V.T.C. and it being sent by post to the address given by the Trader on the Entry Form and once such copy is sent the following conditions shall apply. H.V.T.C reserves the right not to accept the offer in which case H.V.T.C may return the payment or in the case of a cheque (at its discretion) destroy it.
3. Lampport Hall allows the Trader to sell the type of goods and/or provide the type of service as described in the Entry Form from the Stand.
4. The Trader shall sell the type of goods and/or provide the type of services as described on the Entry Form from the Stand during the period of the Festival.
5. Lampport Hall shall allow the Trader access to the Site at the dates and on the times shown on the Entry Form for the purpose of setting up its Stand.
6. Either party might be cancel this contract at any time before 26th May 2018 sending to the other by first class post a notice stating that this contract is cancelled. If sent by H.V.T.C it should be addressed to the address given on the Entry Form. If sent by the Trader it should be addressed to:
"H.V.T.C. Rally Organiser 2018, 21 Mulso Road, Finedon, Northants NN9 5DP. Neither party shall have any liability in the event of such cancellation except that:-
- If H.V.T.C. cancel then H.V.T.C will refund any payment made by the Trader to H.V.T.C.;
 - If the Trader cancels then H.V.T.C will try to find another user for the Stand and only if it is able to do so it will refund to the Trader the payment made by the Trader less a £20.00 administration fee.
7. H.V.T.C do not accept any responsibility for loss or damage to property on the Site at any time and the Trader shall be responsible for the insurance of its own goods on the site.
8. The Trader must have in place **public liability insurance of at least £2.5million**. The Trader must send proof of such insurance with the booking form and the Trader's insurance should indemnify H.V.T.C/Lampport Hall in the event of a claim.
9. H.V.T.C AND Lampport Hall will allow camping by the Trader on the Site between midday on 24th May and midday on 29th May 2018.
10. The Trader will comply with any directions given from time to time by or on behalf of Lampport Hall and H.V.T.C. in relation to the conduct of the Festival or the use of the Site and the following directions will apply:-
- Camping shall be in a location to be specified.
 - The Trader's Stand will be set up in a location to be specified.
 - The Site must be left in a clean and tidy condition.
 - The Trader must sign in and out with a steward.
 - No tombola society stands will be allowed without prior permission.
 - Vehicles **must** be parked in the parking area **before the Festival opens**.
 - The Trader shall conduct business in accordance with all relevant legislation and regulations (in particular relating to the quality of goods and services provided and the Sale of Goods legislation).
 - The Trader shall sell only those goods and/or provide only those services as described on the Entry Form and only from the Stand.
 - The Trader shall not remove goods from the Stand and/or stop providing the services before the advertised end of the Festival.
